Attention of branches/offices is invited to circular no. 150-010-BC dated 23.06.2010 wherein it is informed that Holiday Home at Shimla and Goa will be established as part of Staff Welfare measures.

We are pleased to inform that, the Bank has set up the Holiday Home at Goa-Panaji, and the same will be available for occupation from 01.04.2011.

The Holiday Home consists of one Suite for Executives and two Deluxe rooms for others in **Le Magnifique** Hotel, No.406/230, Plot No. 90, Nova Cidade, Behind PDA Colony, Alto-Porvorim, Bardez-Goa, 403521 (Mobile No:9822142938/9881493938, Website: www.lemagnifiquegoa.com). It is situated close to National High Way -17 and distance from Panaji Bus stand is 3.5 kms and 19 kms from Thivim/Karmail Railway Station. It may be noted that the Holiday Home comes within the geographical jurisdiction of Regional Office, Goa.

The Bank has fixed the occupancy rent from the employees/superannuated employees at a rate of ₹200/- and ₹100/- per day for suite and deluxe room respectively.

The facility can be availed by employees/superannuated employees on LFC/ holidaying/rest and recuperation.

Employees/Superannuated employees who are desirous of availing the facility shall request the Regional Office, Goa-Panaji, at least 15 days prior to the date of visit to the Holiday Home but not earlier than 60 days in the prescribed form. However, the preference shall be given to employees on LTC but on first-come-first served basis. All terms and conditions laid down in Cir.No.212/2007/BC dated 13.09.2007 will apply to this Holiday Home as well.


The proposal to establish Holiday Home at Shimla is dropped due to cost factor.
